Dear Representatives Eshoo, Fitzpatrick and Blunt Rochester:

I am writing to offer [Vizient's](#) support for the Strengthen Kids' Mental Health Now Act of 2022 (H.R. 7236). Your bipartisan legislation would take important steps to address certain mental health challenges among children and young adults and would provide additional financial support to expand the delivery of youth emotional and behavioral healthcare services.

The additional access to behavioral health services provided under your bill, particularly through growing the pediatric mental health workforce and investing in the pediatric mental health infrastructure, will lead to better health outcomes and increased patient flexibility.
